Tender submission deadline is 27 September 2018 until 9.30 a.m.
The back of the envelope shall have the exact name and the address of the tenderer, telephone and fax of the tenderer, as well as name and surname of the contact person.
If tender is submitted by the group of tenderers, the back of the envelope shall include the fact that it is the case of the group of tenderers and the addresses of all the members of the group of tenderers.

Place, time and manner of Tender opening:

Timely submitted tenders will be publicly opened by the Public Procurement Committee on 27 September 2018 at 10.00 a.m. at the premises of Public Enterprise Electric Power Industry of Serbia, Belgrade, Balkanska 13, II floor.

Conditions under which Tenderer's representatives may participate in Tender opening procedure:

Tender opening is a public event and all interested persons can attend it. Only authorized representatives of the Tenderer may actively participate in the opening procedure. Tenderers' representatives that take part in the public tender opening procedure shall submit a power of attorney in writing for the participation in this procedure to the Public Procurement Committee.
Tender opening is public.

Deadline for issuing the decision:

The employer will adopt contract award decision within no longer than 25 (twenty-five) days as of the date of public tender opening.
