Tenderers' representatives that take part in the public tender opening procedure shall, prior to the public tender opening procedure, submit a power of attorney in writing for the participation in this procedure to the Public Procurement Committee, issued on the Tenderer's letterhead, filed, sealed and signed by the legal representative, another representative registered with the register of the competent body or the person authorized by the legal representative, submitting the power of attorney within the tender.
