The manner of tender submission and deadline for tender submission:

Tender with proofs of fulfilment of conditions shall be submitted by Tenderer, in person or by mail, in a closed and sealed envelope/box, closed in such manner so that it can be safely concluded with certainty at its opening that it is being opened for the first time, to the following address: Javno preduzeće "Elektroprivreda Srbije", 11000 Beograd, Srbija, Balkanska 13, labelled with: public procurement "Mobile-telephone services", No. CPP/12/2016, DO NOT OPEN".

Back of the envelope or the box shall have the name, address and phone number/e-mail of the Tenderer.

Tender shall be deemed timely if received by the Employer until 20th July 2017, until 10.30 a.m.

Place, time and manner of tender opening:

Public opening of timely submitted tenders shall be carried out by the Public Procurement Committee, on 20th July 2017, at 11.00 a.m., at the premises of the Public Enterprise Electric Power Industry of Serbia, Belgrade, Balkanska 13, meeting room on the II floor.

Conditions under which Tenderer's representatives may participate in tender opening procedure:

Tender opening is public and may be attended by any interested person. Only authorized representatives of Tenderers may take active part in the tender opening procedure. Representatives of the Tenderers who participate in the public procedure of Tenders opening shall, prior to the beginning of public procedure of Tenders opening, submit a power of attorney in writing for participation in (and not merely attending) this procedure to the Public Procurement Committee, sealed and signed by authorized person of the Tenderer.

Deadline for the adoption of decision :

The decision on contract award shall be made within 25 days from the date of opening of tenders.
