Back of the envelope shall have the basic information on Tenderer, name and surname and telephone number of contact person. In case of a Tender submitted by the group of Tenderers, it should be noted on the back of the envelope that it is the case of group of Tenderers and the basic information on tenderers and contact telephone numbers should be listed.

Untimely tenders, the Public Procurement Committee shall upon the completion of the opening procedure, return without opening to the Tenderer with the note that they are submitted untimely. The last day of the deadline for submission of tenders, the date and time for submitting tender is **08.11.2018 for until 10 a.m.** 

**Time and manner of opening tenders**: Public opening of timely tenders will be performed on 08.11. 2018 at 11 a.m. in the premises of the Public Enterprise Electric Power Industry of Serbia "Belgrade Balkanska 13 in meeting room on the second floor.

Tenderers' representatives that want actively to take part in the public tender opening procedure shall prior to the public tender opening procedure submit a power of attorney in writing for the participation in this procedure to the Public Procurement Committee issued on the Tenderer's letterhead, sealed and signed by the authorized person of the Employer. Persons attending the public tender opening, without power of attorney submitted, shall have no right to comment nor to object the course of tender opening

Deadline for the adoption of decision: The Employer shall adopt the decision on the award of framework agreement within the period stipulated by the law
