Place, time and method of tender opening:

The Public Procurement Commission will publicly open the tenders on 04. September 2018, at 10:30 at the premises of the Javno preduzece "Elektroprivreda Srbije", Beograd, Balkanska 13,

Conditions under which the tenderers' representatives can attend the tender opening procedure:

Opening of tenders is public and can be attended by any interested person. Only authorized representatives of the tenderers can actively participate in the opening procedure. Representatives of tenderers participating in the public tender opening procedure shall submit to the Commission a special written authorization to participate in the tender opening procedure and an negotiation authorization issued on the tenderer's letterhead, registered and certified by the seal and signature of the authorized person of the tenderer. If the authorized representative of the tenderer does not attend the negotiation procedure, the price specified in the submitted tender shall be considered its final price.

Tender opening is public.

Deadline to make a decision:

The Employer shall issue the contract award decision within a maximum of 25 (in letters: twenty-five) days from the public tender opening date.
