Name, address and telephone number/fax of the Tenderer, as well as the full name of the authorized contact person, is to be written at the back of the envelope.

In case that the Tender is submitted by a group of Tenderers, it is advisable it should be noted at the back of the envelope as well, along with the names and addresses of all members of the group of tenderers.

Tender shall be deemed timely if received by Employer no later than 21 November 2018 until 10.00 AM.

Place, time and manner of Tender opening:

The timely submitted tenders will be opened publicly by the Public Procurement Commission on **21 November 2018 at 11.00 AM** at the premises of Javno Preduzeće "Elektroprivreda Srbije", Belgrade, 13 Balkanska st., II floor room.

Conditions under which Tenderer's representatives may participate in Tender opening procedure:

Tender opening is public and can be attended by any interested party. Only authorized representatives of the Tenderers may take an active part in the tender opening procedure. Representatives of the Tenderers who participate in the public procedure of Tenders opening shall, prior to the beginning of public procedure of Tenders opening, submit a power of attorney in writing for participation (and not merely attending) in this procedure to the Public Procurement Committee, sealed and signed by authorized person of the Tenderer.

Deadline for issuing the decision:

Contract award decision will be adopted within 25 days as of the date of public tender opening.
