Tenderers' representatives that want to take part in the public tender opening procedure shall prior to the public tender opening procedure submit a power of attorney in writing for the participation (and not just presence) in this procedure to the Public Procurement Committee issued on the Tenderer's letterhead, filed, sealed and signed by the authorized person of the Tenderer.


