Place, time and manner of Tender opening:

The timely submitted tenders will be opened publicly by the Public Procurement Commission on 05.december 2018 at 10:00 h at the premises of Javno Preduzeće "Elektroprivreda Srbije", Belgrade, 13 Balkanska st., second floor.

Conditions under which Tenderer's representatives may participate in Tender opening procedure:

Tender opening is public and can be attended by any interested party. Only authorized representatives of Tenderers may take active part in the tender opening procedure.

Representatives of tenderers participating in the public tender opening procedure must, prior to the public opening procedure, submit a written authorization to participate in this procedure to the Public Procurement Commission, issued on the Tenderer's memorandum, registered and certified by the seal and signature of the authorized person of Tenderer.

Tender opening is public.

Deadline for issuing the decision :

The employer will adopt contract award decision within no longer than 25 (twenty-five) days as of the date of public tender opening.
