Name, address and telephone number/e-mail of the Tenderer is to be written at the back of the envelope. If tender is submitted by the group of tenderers, the back of the envelope shall include the fact that it is the case of the group of tenderers and the addresses of all the members of the group of tenderers.

The Tender submission deadline is 12 December 2018 at 10 A.M.

Tenders not submitted timely will, upon finalizing the Tender opening procedure, be returned without opening to the Tenderer by the Public Procurement Committee, with a note that they were not submitted timely.

Place, time and manner of Tender opening:

Public opening of timely submitted Tenders will occur on 12 December 2018 at 11.00 a.m. at the premises of Public Enterprise Electric Power Industry of Serbia, Belgrade, Balkanska 13, conference room, II floor.

Conditions under which Tenderer's representatives may participate in Tender opening procedure:

Representatives of the Tenderers who want to participate in the public procedure of Tenders opening shall, prior to the beginning of public procedure of Tenders opening, submit a power of attorney in writing for participation in this procedure to the Public Procurement Committee of the Employer, issued on the Tenderer's letterhead, sealed and signed by authorized person of Tenderer. Persons attending the public opening of tenders, without having submitted the power of attorney, shall have no right to comment nor to object the course of tenders opening.

Deadline for issuing the decision:

Decision relating to contract award shall be made by the Employer within legal deadline.
