Name, address and web site of the Employer: Public Enterprise Electric Power Industry of Serbia, Belgrade, 2 Carice Milice, 11000 Belgrade, www.eps.rs;

Type of Employer: Public Enterprise,

Public procurement procedure type: low-value public procurement.

Criteria, elements of the criteria for contract award: Lowest offered price

The manner and deadline for tender submission: Tenderer can submit only one tender. Tender can be submitted by the Tenderer independently, by the Group of Tenderers, and by the Tenderer with Subcontractor. Tenderer who independently submitted the Tender cannot simultaneously participate in joint tender or as a subcontractor. If the Tenderer fails to comply with the given instruction each tender that includes him will be rejected. Tenderer can be a member of just one group of tenderers submitting joint tender, i.e. he can participate in just one joint tender. If the Tenderer from the Group of Tenderers submitted two or several joint tenders, the Employer will reject all such Tenders. Tenderer who is a member of a group of tenderers cannot at the same time participate as subcontractor. If the Tenderer fails to comply with the given instruction each tender that includes him will be rejected.

Tenderer shall submit the tender in a closed envelope or box that should be closed in a way that it can be determined with certainty that it is being opened for the first time, to the following address: Javno preduzeće Elektroprivreda Srbije, Balkanska 13, records division, labelled with: Tender for the public procurement of services - Economic Consulting in Proceedings related to the Competition Law and State Aid, in accordance with the Treaty Establishing Energy Community – Public procurement number JNMV/1000/0070-1/2017 – DO NOT OPEN.

Deadline for tender submission is 18.12.2017. until 13.00hrs.

Place, time and manner of tender opening: Public Procurement Committee will publicly open timely submitted tenders at the premises of the Public Enterprise Electric Power Industry of Serbia, 13 Balkanska, on 18.12.2017. at 13:30 hrs.

Conditions under which Tenderer's representatives may participate in tender opening procedure:

Tenderer's representatives who participate in the procedure for public opening of tenders shall prior to beginning of public opening procedure submit to the Public Procurement Committee a written power of attorney for participation in this procedure (it should be issued on tenderer's letterhead), filed, sealed and signed by the legal representative of the tenderer or other representative registered with the competent body or person authorized by the legal representative with submission of power of attorney in the tender

Deadline for the adoption of decision: 10 days from the day of tender opening
