Subject: additional clarifications no. 9 in accordance with Article 63 paragraph 3 of Public Procurement Law ("Official Gazette of the Republic of Serbia" number 124/12 & 14/15) in an open public procurement procedure for the procurement of consulting services "Improving financial management and control in EPS group (internal controls and processes, reorganization, cost center/profit center, budgeting and reporting)" - Definition and implementation of EPS CFO organization model - PP number 85/14/DEFP, for which Invitation to Tender was published on Public Procurement Portal on 14.04.2015.

Five and more days prior to expiry date foreseen for submission of tenders in subject public procurement procedure, interested party has submitted to the Employer via e-mail request for additional information, i.e. clarifications, regarding which the Employer, i.e. Public Procurement Committee, in accordance with provision of Article 54 paragraph 12 item 1) of the Law shall provide the following information i.e. clarifications within three days from the day of the receipt of the request:

Question 1:

I'm the representative of ... who will apply as a member of the group of tenderers in PP 85/14/DEFP, jointly with ...

We haven't realized that deadline extension was done on the last moment (18.6.2015, 5 day prior tender opening) and we have already submitted the bid according previous extension deadline, today 23.6.2015.

Due to already 3rd extension, many documents have expired = they were issued before 15.5.2015 (which is more than 60 days prior to 14.7.2015). It means, they don't meet the condition "can't be older than two months before tender opening".

So, we would like to withdraw whole the bid and repack it with fresh documents. But the tender documentation doesn't says how we can do it.

Answer 1:

Paragraph 8 point 3.3 of Section 3 of the Tender documentation governs the way for Tender cancelation.

In this respect, Tenderer who wishes to cancel the submitted Tender, submits Tender cancelation in closed and sealed envelope to the following address:

Submitted cancelation of Tender must contain information about the number and date of the Tender to be cancelled, as well as data on the name and number of the public procurement procedure in which the submitted Tender is cancelled.

Cancellation of the Tender must be stamped and signed by the legal representative, other representative registered at the register of the competent body or person authorized by the legal representative along with submission of Power of Attorney in the cancellation of the Tender.

In case of submitted Tenders cancelation prior to the expiry of the Tender submission period, the Employer shall not open such Tender, and it shall return it unopened to the Tenderer.

These additional clarifications are submitted by email to the applicant and are published on Public Procurement Portal and web site of the Employer.
