Tenderers' representatives that take part in the public tender opening procedure shall prior to the public tender opening procedure submit a power of attorney in writing for the participation in this procedure to the Public Procurement Committee issued on the Tenderer's letterhead, filed and certified by the seal and signature of the Tenderer's legal representative or other representative registered with the register of the competent body or the person authorized by the legal representative with submission of the power of attorney in the tender.
