The back of the envelope shall include the correct name and address of the tenderer, telephone and e-mail/fax of the tenderer, as well as the name and surname of the authorized contact person.

Deadline for tender submission is 20.03.2017 until 12hrs.

Place, time and manner of Tender opening:

Public Procurement Committee shall open timely submitted tenders publicly on 20.03.2017 at 12:30 p.m., at the premises of Javno preduzeće Elektroprivreda Srbije, Beograd, 13 Balkanska Street.

Conditions under which Tenderer's representatives may participate in Tender opening procedure:

Tenderers' representatives who take part in the public tender opening procedure shall prior to the public tender opening procedure submit a power of attorney in writing for the participation in this procedure to the Public Procurement Committee, issued on the Tenderer's letterhead, filed, sealed and signed by the legal representative of the Tenderer or other representative registered with the register of the competent body or person authorized by the legal representative along with the submission of power of attorney in the tender.
