The Tenderer shall submit Tender for each Lot separately. Along with the written Tender, the Tenderer also submits CD or USB PDF format Tender in the closed and sealed envelope (it is preferable that the pdf format enables search option). Back of the envelope shall have mandatorily correct name and address of the Tenderer. telephone and fax numbers of the Tenderer, as well as name and surname of the authorized contact person. In case of a Tender submitted by group of Tenderers, it should be noted on the back of the envelope that it is the case of group of Tenderers and the names and addresses of all members of the group of Tenderers should be listed. The Tenderer may submit only one tender. Tender shall be deemed timely if received by the Employer until 15th November 2016 up to 12.00 hrs. Place, time and manner of Tender opening: Public Procurement Committee shall open timely submitted tenders publicly on 15h November 2016 at 13.00 hrs at the premises of the Javno preduzeće "Elektroprivreda Srbije", Beograd, Balkanska 13, II floor, conference room. Conditions under which Tenderer's representatives may participate in Tender opening procedure:

Tender opening is public and may be attended by any interested person. Only authorized representatives of Tenderers may take active part in the tender opening procedure. Representatives of the Tenderers who participate in the public procedure of Tenders opening shall, prior to the beginning of public procedure of Tenders opening, submit a power of attorney in writing for participation (and not merely attending) in this procedure to the Public Procurement Committee, sealed and signed by authorized person of the Tenderer.
