The manner of Tender submission and deadline for Tender submission:

Tenderer shall submit the tender in person or via mail in a closed envelope or box that should be closed in a way that it can be determined with certainty that it is being opened for the first time.

Back of the envelope or box shall have the name and address of the Tenderer.

In case of a Tender submitted by the group of Tenderers, it should be noted on the back of the envelope that it is the case of group of Tenderers and give the names and addresses of all participants in the joint tender.

Tender shall be submitted to the following address: Javno preduzeće Elektroprivreda Srbije, Beograd, Balkanska 13, 11000 Beograd, records division, ground floor, labelled with: Tender for the public procurement of works - Inspection and overhauls of 20/10 and 1 kV and repair maintenance 20/10 and 1 kV for the distribution area of Niš and Kragujevac, PP/8000/0018/2016. Tender shall be deemed timely if received by the Employer no later than 09.12.2016 until 10 hrs.

Place, time and manner of Tender opening:

Public opening of timely submitted tenders will be done by Public Procurement Committee on 09.12.2016 at 11 hrs, at the premises of Javno preduzeće Elektroprivreda Srbije Beograd, Balkanska 13.

Conditions under which Tenderer's representatives may participate in Tender opening procedure:

Tenderers' representatives that take part in the public tender opening procedure shall prior to the public tender opening procedure submit a power of attorney in writing for the participation in this procedure to the Public Procurement Committee (and not just power of attorney for presence) issued on the Tenderer's letterhead, sealed, stamped and signed by the authorized person of the Tenderer.
