Back of the envelope shall have the basic data on Tenderer, name and surname, and phone number of the contact person. In case of a Tender submitted by the group of Tenderers, it should be noted on the back of the envelope that it is the case of group of Tenderers and the basic information on tenderers and contact telephone numbers should be listed.

The last day of the deadline for submission of tenders, i.e. the last date and hour for tender submission, is 11<sup>th</sup> August 2017, until 9.00 a.m.

In the event of untimely tender, the Public Procurement Committee shall upon the completion of the opening procedure, return without opening to the Tenderer with the note that it was submitted untimely.

Place, time and manner of tender opening:

Public opening of timely submitted tenders shall be carried out on 11<sup>th</sup> August 2017, at 11.00 a.m., at the premises of the Public Enterprise Electric Power Industry of Serbia, Belgrade, Balkanska 13, meeting room on the II floor.

Conditions under which Tenderer's representatives may participate in tender opening procedure:

Tenderers' representatives that want to take part actively in the public tender opening procedure shall prior to the public tender opening procedure submit a power of attorney in writing for the participation in this procedure to the Public Procurement Committee issued on the Tenderer's letterhead, sealed and signed by the authorized person of the Tenderer. Persons attending the public tender opening, without power of attorney submitted, shall have no right to comment nor to object the course of tender opening.

Deadline for the adoption of decision :

The decision on contract award shall be made by the Employer within legal deadline.
