Subject: amendment to the Tender Documents no. 1 in accordance with Article 63 paragraph 1 of Public Procurement Law ("Official Gazette of the Republic of Serbia" number 124/12) in an open public procurement procedure for the procurement of consulting services "Improving financial management and control in EPS group (internal controls and processes, reorganization, cost center/profit center, budgeting and reporting)" - Definition and implementation of EPS CFO organization model - PP number 85/14/DEFP, for which Invitation to Tender was published on Public Procurement Portal on 14.04.2015.

Tender Documents in the open procedure of the Public Procurement No. 85/14/DEFP are being modified as follows:

- 1. Item 3.12, paragraph with the subtitle "Knowledge of the language" is deleted.
- 2. Item 3.18 section 3 of Tender Documents, element of criteria C.3 Staff quality, subelement C.3.1 Experience of staff members, description of definition for SCFOP is amended as follows:
 - "<u>Silimal CFO Organization Model Project (SCFOP)</u>": similar organization project in the CFO area of large integrated group (integrated group with more than 2.500 employees), including processes and tools, covering both conceptual and implementation activities.
- 3. Item 3.18 section 3 of Tender Documents, element of criteria C.3 Stafff quality, subelement C.3.1 Experience of staff members, a new definition is added as follows:

Knowledge of the Language – fluent in Serbian: team member is fluent in Serbian, including, but not limited to, Serbian as mother tongue. Knowledge of Croatian, Bosnian and/or Montenegrin language is not an alternative to the said requirement regarding knowledge of Serbian language. In CV submitted in the Form No. 7.3. as per the Tender Documents, grades 4 and 5 mean that the team member is fluent in Serbian.

Tender Documents in the open procedure of the Public Procurement No 85/14/DEFP only in Serbian version of the text are modified as follows:

4. Item 3.18 section 3 of Tender Documents, element of criteria KC.3 Staff quality, subelement KC.3.1 Experience of staff members, Scoring 30 weights part, Other team members – Serbian speaking criteria, the first paragraph is amended to read:

"Minimum 1 other team member under the item 3.12 paragraph 2 indent 4, meets the following criteria:"

Tender Documents in the open procedure of the Public Procurement No 85/14/DEFP only in English version of the text are modified as follows:

5. Section 4, item 4.3 Instructions on how to prove the fulfilment of conditions, part relating to fulfilment of additional requirements for participation, evidence of adequate financial

capacities, indent 2 for domestic and foreign tenderers, the period for wich the evidence of liquidity data should be issued is modified and reads as:

"October 2014 - March 2015"

6. Title of the form 1 is modified as follows:

"STATEMENT ON INDEPENDENT TENDER"
